### **Job Description**

Employer in Mt. Vernon is seeking candidates for a Warehouse Worker / Truck Driver position. During non-holiday weeks, the applicant can expect to work from 35 to 45 hours per week. Work schedule is rotating, Monday through Sunday. Candidate must:

- be willing to perform warehouse work (minimum of 50% of the time) plus make deliveries in the company's commercial trucks.
- be in good enough physical shape to deliver 20-30 stops on a route by hand.
- have a clean driving record within the last 5 years.
- be able to lift 50 lbs on a consistent basis. While working in the warehouse, employee will be on their feet 99% of the time.
- live within a 30-mile radius of Mt. Vernon.
- have an air brake endorsement be licensed to operate a manual transmission truck.
- be dependable.
- have an up-to-date CDL physical. If not, employer will require the applicant to obtain one before employment start date. After the 3-month probationary period, employer will reimburse the applicant for the expense of the CDL physical.
- have a current Illinois drivers license with the appropriate license classifications as listed below.

Starting pay rate based on drivers license classification / CDL classification is shown below:

- IL Class A CDL = \$13.00 per hour. After 3-months, when put on employer's payroll, rate would increase to \$13.50 per hour.
- IL Class B CDL = \$12.50 per hour. After 3-months, when put on employer's payroll, rate would increase to \$13.00 per hour.
- IL Class C License = \$12.00 per hour. After 3-months, when put on employer's payroll, rate would increase to \$12.50 per hour.

### **Requirements**

High School Diploma or GED is required.
